RCI® Points Partner Program Terms & Conditions

These RCI Points Partner Program Terms & Conditions are intended to supplement and not replace the Terms and Conditions of RCI Points® Subscribing Membership and RCI Platinum® Membership Rules available at rci.com.

1. Your booking and exchange of Points for RCI Points Partner products and/or services are subject to the terms and conditions set forth in the Terms and Conditions of RCI Points Subscribing Membership, and/or the RCI Platinum Membership Rules (if you are an RCI Platinum Member), together with these RCI Points Partner Program Terms & Conditions. In addition, you are also subject to the terms and conditions of the applicable RCI Points Partner, including but not limited to restrictions due to black-out dates or unavailability.
2. RCI may at any time, in its sole discretion, add, amend or terminate any RCI Points Partner product(s) and/ or service(s).
3. RCI and each RCI Points Partner are separate and distinct entities, and RCI may have no control over the operation of certain of the RCI Points Partners.
4. Based on their applicable Home Group and certain other characteristics determined by RCI in its discretion, RCI Points Members who are eligible to use the RCI Points Partner Program may be restricted from using some or all of the total number of points available to them towards RCI Points Partner Program transactions. For terms and conditions that apply to GEO Members, please call 877-894-1793.
5. Renting Points from RCI for the RCI Points Partner Program transactions is not permitted. Using borrowed, saved or extended Points for RCI Points Partner Program transactions is permitted; however, in no event shall the maximum Points used in each calendar year exceed the applicable amounts as described in Paragraph 4 above.
6. Eligible Members may exchange Points for discounts off the value of travel products and services. For each RCI Points Partner transaction, there will be a specified maximum number of Points that may be used, as well as a minimum number of Points required. In addition, for each RCI Points Partner transaction, there may be a cash component required as used in the RCI Points Partner Program, the number of Points, as well as the discounts, may change from time to time in RCI's sole discretion, based on factors such as the product type, price and timing of the RCI Points Partner opportunities RCI guides will be available, at 844-840-6142 or other numbers published by RCI from time to time to assist Members. In addition, depending on availability, Members may have online access at www.rci.com to the most current RCI Points Partner discounts, all discounts, Point amounts and values remain subject to change without notice at the sole discretion of RCI.
7. After the discount has been deducted from the cost of the transaction, any remaining cost must be paid by the member with cash (by debit card) credit card, or any other method of payment accepted by RCI in its discretion at the time of the transaction. For example, if a hotel night has a retail value of \$125 and the member chooses to exchange 2,000 Points for a \$25 discount

(please note that actual discounts will vary depending on the details of each transaction), the remaining \$100 may be paid by cash or credit card.

8. Unless otherwise stated, Members will not earn Travel Rewards on RCI Points Partner transactions.
9. Additional restrictions and/or terms and conditions may apply for any particular RCI Points Partner transaction. See the individual RCI Points Partner provider for such restrictions and/or any other additional terms and conditions.
10. Products and/or services offered by RCI Points Partners are subject to availability and certain blackout dates may be imposed by RCI or the RCI Points Partner without further notice.
11. RCI transaction fees, as promulgated by RCI from time to time in its discretion, may apply to the usage of Points for RCI Points Partner transactions.
12. Unless otherwise stated at the time of booking, all RCI Points Partner transactions are completely non-refundable, non-changeable and nontransferable and are subject to the terms and conditions of the carrier/provider in addition to any RCI terms and conditions.
13. Subject to the additional restrictions set forth herein, any Points exchanged for Points Partner transactions will be subject to a limited grace period where by any Points Partner transaction cancelled by the close of business the following day may be eligible for a full refund of any Points exchanged. After the close of business the following day, all Points exchanged will be forfeited in the event of a change or cancellation. Notwithstanding the foregoing, if a Points Partner transaction is made within three days of the date of travel, such transaction is final and no grace period will apply to the exchanged Points. Any other amounts paid, whether by cash (by debit card) or credit, will be subject to the cancellation policy of the RCI Points Partner and will not be subject to any grace period.

It is the member's responsibility to investigate the safety and suitability of any activity, and the credentials and fitness of any guide, vendor or service provider, and members participate at their own risk.
